My name is Jo Parry and I work for Bromford as a regeneration coordinator. I am writing to let you know about the next phase of our regeneration programme, which will mean some changes for you, your family and your home.

I'm sure you are already aware that your home and some of the other houses on your road are called 'Cornish' houses which are made of a concrete non-traditional construction (non-traditionally built properties means that they are not made with a conventional brick or timber frame structure). Five years ago we wrote to a number of our customers living in non-traditional homes advising them of our intentions to carry out an in-depth review of our non-traditional properties in the area with the view to redevelop.

Your property is one of the homes affected and following the review we issued an initial demolition notice (IDN) to all affected properties in March 2013 in recognition that they were now part of our overall regeneration programme for South Gloucestershire. An initial demolition notice is nothing to worry about, it's just the legal bit that lets you know that at some point in the future we propose to redevelop some of the road where you currently live as well as putting on hold any Right to Buy applications made by customers.

We last updated you in November 2016 and it was at this point we reassured customers that we would be back in touch with you as soon as we had a confirmed programme for redevelopment.

As I'm sure you can imagine, a lot of background work has taken place since then and we are now in a position to talk to you about your housing needs, with a view to finding you an alternative home in the local area that meets your requirements and that you are happy to call home. Our priority over the next few weeks is to meet with you and your neighbours to better understand your individual circumstances and to really get a sense of any thoughts or concerns you may have.

I would like to visit you on 07/02/2019 at XX:XX to talk to you about your initial demolition notice and what the process will look like moving forward. This will also be a great opportunity to talk to us about your thoughts on the regeneration programme, ask any questions we may not have answered so far, and to discuss any concerns you may have.
