Dear customer,

My name is James Trotter and I am a regeneration coordinator at Bromford. I am writing to let you know about our proposals for Stockwells which may mean some changes for you, your family and your home.

I'm sure you are already aware that your home and some of the other houses on your road are called 'Cornish' houses which are made of a concrete non-traditional construction. This means that the properties are not made with a conventional brick or timber frame structure. This type of property tends to be expensive to maintain and upgrade.

We believe that we can best meet the needs and aspirations of our customers by providing modern and energy efficiency homes for our customers.
